


A personal bond is granted (signed) by a judge. The bond allows you to get out of jail while your case is pending. When you sign the personal bond before you leave jail, you are agreeing to pay the bond amount to Travis County if you (or your attorney) does not show up to your court dates.

#2: The Bond Amount



The bond amount (\$4000) is written in the middle of the page. You do not need to pay the bond amount unless you (or your attorney) do not show up for court on your court date.

#3: The Court Date



The court date is written in the middle of the page (23rd of December 2020 at 9am). The first court date is almost always reset by the court without you having to go. You will likely receive a text from the court with the new date.




