| Why? | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. |
| What? | The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> ■ Contact information, Social Security number, account balance, payment history, transaction history, credit history |
| How? | All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons CU Loan Source chooses to share; and whether you can limit this sharing. |

What we do

How does CU Loan Source protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does CU Loan Source collect my personal information?

We collect your personal information, for example, when you

- apply for retail financing or
- make a payment or
- provide contact details.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on our account.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- CU Loan Source's affiliates include those companies that control, are controlled by or under common control with CU Loan Source.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Non-affiliates we share with may include vendors or partners that provide products or services we believe may be of interest to you.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Our joint marketing partners include banks, credit unions or insurance companies.
