

# AA Golf Sims – GOLF SIMULATOR SAFETY AGREEMENT - 1

*Keeping You Safe While Enjoying the Game*

AA Golf Sims is committed to providing a fun, safe, and professional golf simulator experience. To ensure the safety of all users and to prevent damage to equipment or property, **please review and follow the guidelines below** during your rental period.

---

## 1. General Safety

- **Supervision is required:** An adult (18+) must be present to supervise all users at all times during the rental period.
- Only **one person may swing at a time** inside the simulator area.
- Keep a **safe distance** from anyone swinging a golf club. Bystanders should stand **at least 6 feet** behind the player.
- **No food, drink, or smoking** near the simulator or equipment.
- No roughhousing, horseplay, or misuse of the simulator space.

## 2. Equipment Use

- Use only the clubs, balls, and accessories provided or approved by AA Golf Sims.
- **Do not attempt to modify, move, or disassemble** any part of the simulator system.
- Keep **hands, feet, and objects away** from any electronic or mechanical components.
- **No hitting real golf balls outside of the designated hitting area.**
- Do not use **damaged clubs, cracked balls**, or any sharp objects that could damage the screen or turf.

## 3. Environmental Requirements

- The simulator must be placed on a **flat, dry, and stable surface**, either indoors or under the provided tent.
- The simulator must remain within **100 feet of an electrical outlet.**
- Avoid use in **extreme weather conditions** such as heavy rain, high wind, or lightning. In such cases, please contact AA Golf Sims for support or rescheduling options.

## 4. Children and Pets

- Children under the age of 12 must be directly supervised by an adult or AA Golf Sims employee/representative.
- Pets must be kept away from the simulator at all times to avoid accidental damage or injury.

## 5. Emergency Situations

- In case of injury or equipment malfunction, **stop play immediately** and notify AA Golf Sims.
- Do not attempt to troubleshoot electronic issues unless instructed by an AA Golf Sims representative.

## 6. Damage and Liability

- Renter is **financially responsible** for any damage caused by misuse, negligence, or failure to follow these safety guideline (*AA Golf Sims discretion*)
- AA Golf Sims is not liable for injuries resulting from unsafe behavior or failure to follow safety instructions.
- **Inherent Risks:** Renter acknowledges that using the golf simulator involves inherent risks, including but not limited to physical injury, and voluntarily assumes all such risks.
- **Release of Liability:** Renter agrees to release, waive, and discharge AA Golf Sims and its affiliates, successors, officers, employees, representatives, partners, and agents from any and all liability for injuries, damages, or losses arising from use of the equipment, including those caused by AA Golf Sims' negligence.
- **Indemnification:** Renter agrees to indemnify and hold harmless AA Golf Sims from any claims, damages, or expenses (including legal fees) resulting from use of the equipment.
