ALL VENDORS are required to submit full payment by Dec. 3rd. The fee is \$75 for a table space. If you split the booth with another vendor, the fee is \$40 per person. Set up time is 10:00 AM and break down is at 5:30PM. Booth spaces include one 6ft white table and 2 chairs. Additional tables may be purchased for \$65 each. We suggest that vendors bring their own lighting and displays. Electricity is provided. Please notify us if electricity is needed. Please remember to collect your own applicable sales tax.

PARKING Please park in the lot to the east of the event center.

PAYMENT METHODS Please pay Nature's Treasures by Dec. 3rd, 2024 via cash, check or credit card. Check payments may be mailed to Nature's Treasures at 4103 N Interstate 35, Austin, Texas 78722; DO NOT MAIL CASH. Cash & check payments may be dropped off during store hours but must be in sealed envelope with your name and phone number. Credit card payments are accepted in-store or by phone during store hours. Full payment must be received prior to the day of the event.

REFUNDS Refunds will only be issued with advance notice of cancellation up to 1 week prior to event. Notices of cancellation received the week of the event, and no shows are ineligible to receive a refund. The 20% Promotional Deposit is non-refundable.
