Terms of Service Agreement

PLEASE READ THE FOLLOWING TERMS OF SERVICE AGREEMENT CAREFULLY. BY ACCESSING AND USING MEDFORD CHEMISTS WEBSITE AND MEDFORD CHEMISTS SERVICES, YOU HEREBY AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT AND ALL TERMS INCORPORATED HEREIN BY REFERENCE.

THIS TERMS OF SERVICE AGREEMENT IS EFFECTIVE AS OF MARCH 1, 2017.

Acceptance of Terms. The following Terms of Service Agreement (the "TOS") shall govern the relationship with our users and others which may interact or interface with Medford Chemists Inc located at 2608 Route 112, Medford, NY 11763, and Medford Chemists subsidiaries and affiliates, in association with the use of the Medford Chemists website (the "Website") and its Services, which are defined below.

<u>Website Services Offered</u>. Any and all visitors to Medford Chemists Website, despite whether they are registered or not, shall be deemed as "users" of the Services contained herein and for the purpose of this TOS. Once an individual register for our Services through the process of creating an account, the user shall then be considered a "member."

The Services provided and made available through Medford Chemists Website and applications, which may include some mobile applications that may be made available, are the sole property of Medford Chemists. Medford Chemists may offer additional Services or update, modify or revise any current content and Services, and this TOS shall apply to any and all additional Services and any updated, modified or revised Services. Medford Chemists hereby reserves the right to cancel and cease offering any of the aforementioned Services. The continued use of the Services provided, after such posting of any updates, changes and or modifications, shall constitute acceptance of such updates, changes and/or modifications.

The Services are provided "AS IS," and as such Medford Chemists shall not assume any responsibility or obligation for the timeliness, missed delivery, deletion and/or any failure to store user content, communication or personalization settings.

<u>Registration</u>. To register and become a "member" of the Website, you must be 18 years of age. In addition, you must be in good standing and not an individual that has been previously barred from receiving Services from Medford Chemists under the laws and statutes of the United States or other application jurisdiction.

In addition, registering party hereby acknowledges, understands and agrees to:

(a) Furnish factual, correct, current and complete information with regard to yourself;

and

(b) Maintain and promptly update registration and profile information in an effort to maintain accuracy and completeness at all times.

Medford Chemists shall have the right to suspend or terminate any user and/or member who shall provide false, untrue, inaccurate or incomplete information, in violation of this TOS, and may refuse current or future use of any or all Medford Chemists Services.

<u>Privacy Policy</u>. Every member's registration data and various other personal information is strictly protected by Medford Chemists Privacy Policy (see the full Privacy Policy). As a member, you consent to the collection and use of the information provided, including the transfer of information for storage, processing or use by Medford Chemists and/or its subsidiaries and affiliates.

Member Account, Username, Password and Security. After completion of the registration data and creation of your username, you will create or receive a random password, which you can later change, and account designation. You will be responsible for maintaining the secrecy and confidentiality of your password and for all activities that transpire on or within your account. It shall be your responsibility to notify Medford Chemists immediately if you notice any authorized access or use of your account or password or any other breach of security. Medford Chemists shall not be held liable for any loss and/or damage arising from any failure to comply with this term and/or condition of the TOS.

Conduct. You agree not to make use of Medford Chemists Services for the purpose of:

- (h) Interfering with or disrupting any Medford Chemists Services, servers and/or networks that may be connected or related to Medford Chemists Website, including, but not limited to, the use of any device software and/or routine to bypass the robot exclusion headers;
- (i) Violating any local, state, federal, national or international law;
- (j) "Stalking" or with the intent to otherwise harass another individual; and/or
- (k) Collecting or storing of any personal data relating to any other member or user in connection with the prohibited conduct and/or activities which have been set forth in the aforementioned paragraphs.

Medford Chemists reserves the right to pre-screen, refuse and/or delete any content currently available through Medford Chemists Services. In addition, we reserve the right to remove and/or delete any such content that would violate the TOS or which would otherwise be considered offensive to other visitors, users and/or members.

Medford Chemists herein reserves the right to access, preserve and/or disclose member account information and/or content if it is requested to do so by law or in good faith belief that any such action is deemed reasonably necessary for:

- (a) Compliance with any legal process;
- (b) Enforcement of the TOS;
- (c) Responding to any claim that therein contained content is in violation of the rights of any third party;
- (d) Responding to requests for customer service; or
- (e) Protecting the rights, property or the personal safety of Medford Chemists, its employees, visitors, users and members, including the general public.

Indemnity. All users and/or members herein agree to hold Medford Chemists, its subsidiaries, affiliates, agents, employees, officers, partners and/or licensors harmless or not liable for any claim or demand, including reasonable attorneys' fees, made by any third party, which may arise from any content a member or user of Medford Chemists Website may submit, post, modify, transmit or otherwise make available through Medford Chemists Services, the use of Medford Chemists Services or your connection with these Services, your violations of the Terms of Service and/or your violation of any rights of another person.

With regards to appropriate circumstances and at its sole discretion, Medford Chemists may disable and/or terminate the accounts of any user who repeatedly violates Medford Chemists TOS and/or infringes the rights of others.

General Information

<u>Entire Agreement</u>. This TOS constitutes the entire agreement between you and Medford Chemists and shall govern the use of Medford Chemists Services, superseding any prior version of this TOS between you and us with respect to Medford Chemists Services. You may also be subject to additional terms and conditions that may apply when you use or purchase certain other Medford Chemists Services, affiliate Services, third-party content or third-party software.

Choice of Law and Forum. With regard to the TOS, the relationship between the parties shall be governed by the laws of the State of New York without regard to its conflict of law provisions and that any and all claims, causes of action and/or disputes, arising out of or relating to the TOS, or the relationship between you and Medford Chemists, shall be filed within the courts having jurisdiction within the County of Onondaga, New York or the U.S. District Court located in said state. You and Medford Chemists agree to submit to the jurisdiction of the courts as previously mentioned, and agree to waive any and all objections to the exercise of jurisdiction over the parties by such courts and to venue in such courts.

<u>Waiver and Severability of Terms</u>. At any time, should Medford Chemists fail to exercise or enforce any right or provision of the TOS, such failure shall not constitute a waiver of such right or provision. If any provision of this TOS is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of the TOS remain in full force and effect.
