External Provider Quality Requirements

TERMS

Q01 Seller shall keep confidential all technical and proprietary information including blueprints, data, designs, drawings, engineering data for production, product know-how and any other information furnished to Seller by Buyer in connection with this contract. Seller shall not use such items or information in the design, manufacture or production of any goods, or for any other purchase or for the manufacture of production of larger quantities than those specified, except with the express consent in writing from the Buyer. Seller, including its agents, employees, and representatives will exercise extreme caution to prevent disclosure of such information to third parties. The obligations of this provision shall survive the completion of performance and expiration or termination of this contract.

Q02 Buyer and authorized representatives of Buyer's Customers and/or Regulatory Authorities shall have direct access to all applicable areas of all Seller's and Seller's Subcontractor's Plants (at any level of the supply chain) where work under this P.O. is being performed, to review progress, records and witness testing of the items related to this P.O. Seller shall include this clause in all of Seller's subcontracted Purchase Orders.

Q03 Seller shall notify Buyer if any non- conformance exists with the product or process and shall obtain disposition approval from Buyer's authorized representative.

Q04 Seller shall notify Buyer of changes in product and/or process, changes of Sellers, changes of manufacturing facility location and, where required, obtain organization approval.

Q05 It is the responsibility of the organization accepting the Purchase Order to flow down all requirements to their sub-contractors.

Q06 Quantity variances and/or partial shipments are not permitted unless prior written authorization is received from the Buyer.

Q07 All goods supplied shall be suitably packaged to protect, marked and shipped in accordance with Buyer's instructions. In the absence of instruction, Seller shall contact the Buyer. All supplied goods will be returned to the Seller for inspection if parts are received damaged.

Q08 Accelerated delivery is not permitted unless noted in P.O or with prior arrangements/approval of Buyer.

Q09 All special processes required by this P.O. must be performed by qualified personnel.

Q010 Seller shall not implement any changes in design, material, processes or control without written approval from Buyer prior to supplying services and/or material. The seller is also responsible for compliance by sub-contractors. Contact Buyer's authorized representative for details regarding deviations to authorized materials. Seller agrees and understands that such deviations only apply to this purchase order and only as indicated in Buyer's authorized document.

Q11 Seller must retain all records for this order for a minimum of 10 years, unless otherwise specified.

External Provider Quality Requirements

Q12 CERTIFICATE OF CONFORMANCE

Seller Certification of Conformance is required with this order. A legible and reproducible Certificate of Conformance or Seller's statement of quality will accompany each shipment. Certifications must show the part number, quantity, specification, and revision number, and have a legible printed and signed with title of responsible person releasing the certification. This certifies the material/services provided by the Seller meet all drawing and/or specifications requirements. Records supporting this certification shall be on file and shall be provided to Buyer upon request at no cost to Buyer.

Q13 PROCESS CERTIFICATIONS

Suppliers and/or their sub-contractors performing any special process to product listed on the purchase order must provide a certification for each process. The certification shall include the following as a minimum:

Supplier's name, address and phone number

HFW's P.O. Number

Part Number, including dash and rev. and HFW Job Number

Quantity

Lot number, batch numbers or serial numbers where applicable

Process name, specification, type, class, method etc. as applicable

Q14 MATERIAL CERTIFICATIONS

Each shipment shall be accompanied by one legible copy of an approved Certificate of Conformance, which certifies that the purchase order items were produced from material for which the supplier has specific data or other objective evidence to the effect that the material conforms to drawings and/or specifications. The certificate shall list the following as a minimum:

Supplier's name, address and phone number

HFW's P.O. Number

Material type and specification number

Size and Quantity

Lot Number (manufacturer/heat/batch number)

Country of material melt

Q15 CHEMICAL AND PHYSICAL TEST REPORTS

Each shipment must be accompanied by one (1) legible and reproducible copy of all chemical and physical test reports identifiable with materials ordered. The reports must contain the signature and title of the authorized representative of the agency performing the test and must assure conformance to specification requirements.

Q16 INSPECTION RECORDS

Inspection records shall be available upon request for each product shipment received. These records shall include the nature and number of observations and traceable by part number to the material / or services being provided by the Seller.

Q17 CALIBRATION

Supplier shall meet and maintain a calibration system in conformance with ISO 10012-1, ISO 17025 or ANSI Z540-1 and must be traceable to NIST (National Institute of Standards Technology). Actual calibration results shall appear on the certificates.

Q22 COUNTERFEIT PARTS AND MATERIALS AVOIDANCE

Components and parts shall be procured only through Original Equipment Manufacturers (OEMs)/Original Component Manufactures (OCMs) or their franchised dealer or distributors.

The Seller shall verify the procurement source and associated certifying paperwork.

Appropriate incoming inspection test methods shall be used to detect potential counterfeit parts and materials. The Seller shall flow this requirement down to all sub tier sellers to prevent the inadvertent use on counterfeit parts and materials.

The Seller shall not use unapproved brokers (any company, person, or entity who is not an OEM/OCM or not an OEM/OCM authorized franchised dealer or distributor) for the purchase of components and parts unless pre-approval has been granted by Buyer

Q23 ITAR AND EXPORT CONTROLS

The parts and technical data covered by this PO are controlled under ITAR and United States Export Regulations and may not be divulged or exported to a foreign person either in the US or abroad without authorization of the US Dept. of State or the US Dept. of Commerce.

Q24 CODE OF CONDUCT
