

AGREEMENT BETWEEN INDIGO SALON AND MEDICAL SPA FOR 2022 MERRY MARKET

Indigo's Merry Market will be held at Indigo Salon and Medical Spa on Thursday, November 3rd.

1. Indigo agrees to furnish the Exhibitor with suitable space for the display and sale of the Exhibitor's merchandise at Indigo's Merry Marketplace, as specified herein, subject to the conditions hereinafter set forth.
2. Indigo assumes no responsibility for the collection of accounts from customers of the Exhibitors and is not responsible for the sale of merchandise.
3. Each Exhibitor is responsible for obtaining at its own expense a retailer's license for the State of South Carolina (which is permanent and does not have to be renewed) as well as any other license that may be required by any governmental agency. Each Exhibitor assumes all responsibility for collecting and remitting to proper South Carolina taxing authorities the 8% sales tax on all gross receipts at the close of the Indigo Merry Marketplace. Indigo is in no way liable for failure of the Exhibitor to follow any state, local or federal law in regards to the responsibilities of the Exhibitor listed in this paragraph.
4. The Exhibitor shall assume all risks with respect to Exhibitor's merchandise, all expenses in connection with the transportation, packing, unpacking, display and sale of exhibitor's merchandise and any insurance thereon desired by the Exhibitor shall be borne by the Exhibitor. THIS INCLUDES BUT IS NOT LIMITED TO THE EXHIBITORS ASSUMING ALL RISKS WITH RESPECT TO ANY MERCHANDISE OR MONEY THAT IS DUE TO AN EXHIBITOR FROM THE SALE OF ANY MERCHANDISE, ANY MERCHANDISE OR MONEY IS STOLEN, ANY MERCHANDISE OR MONEY IS MISPLACED OR ANY MERCHANDISE OR MONEY THAT IS DAMAGED. THE EXHIBITOR AGREES TO NOT HOLD INDIGO RESPONSIBLE FOR ANY OF THE ABOVE LISTED OCCURRENCES AND THE EXHIBITOR INCLUDES TO TAKE FULL RESPONSIBILITY FOR ANY SUCH OCCURRENCE AND TO NOT TAKE LEGAL ACTION AGAINST THE LEAGUE FOR ANY SUCH OCCURRENCE AND TO HOLD HARMLESS AND INDEMNIFY INDIGO FOR ANY DAMAGES THE EXHIBITOR SUSTAINS DUE TO THE FOLLOWING, BUT NOT LIMITED TO MERCHANDISE OR MONEY THAT IS DUE FROM A CUSTOMER SALE, STOLEN, LOST, MISPLACED, OR DAMAGED.
5. The Exhibitor shall be responsible for liability insurance and assumes all responsibility for any injury or damage that is sustained or incurred by virtue of his/her display and sale of goods at Indigo's Merry Market. Further, each Exhibitor shall indemnify and hold Indigo harmless from any and all injuries or damages, including all attorney's fees that are sustained or incurred by virtue of the aforesaid.
6. In order to avoid undue duplication of displays, Exhibitors will be limited to the display of Exhibitor's own merchandise. Exhibitor will not display the merchandise of any other party nor share its booth with any other party without the prior written consent of Indigo and unless such party has agreed in writing to be bound by the terms of Agreement.

7. Exhibitor must move in and arrange his/her merchandise on Thursday, November 3rd,2022 between the hours of 3 pm and 5 pm. The merchandise must be removed between the hours of 7 pm and 8 pm on Thursday.
8. Exhibitors, or their authorized representatives must be always present in their booths during Indigo's Merry Market. At no time may the booth be left unattended.
9. In order to ensure a reservation of space for the Exhibitor at Indigo's Merry Market, this Agreement must be signed by the Exhibitor, or his/her duly authorized representative, and returned to Indigo Salon and Medical Spa within 14 days of receipt of contract. Indigo has sole discretion in assigning booth space to each Exhibitor.

11. Indigo reserves the right at any time to cancel this Agreement, provided written notice of such cancellation is given to the Exhibitor. The Exhibitor agrees to hold Indigo harmless from any such cancellation for all damages the Exhibitor may claim to sustain.
12. Exhibitor must guarantee that all orders be filled within 30 (thirty) days after Indigo's Merry Market, unless other arrangements are made with the customer. If delivery cannot be made within 30 (thirty) days, the customer must be notified immediately.
