- **Team Evaluations/ Tryout Clinic/Work Week**

\_\_\_\_\_ I hereby give permission for my son/daughter to attend the Cheer Station team try-out clinic. I have completed a release form that makes Cheer Station and its representatives paid or volunteer, not liable for injuries to my child. I give permission for my child's picture to be used for promotional and educational purposes in Cheer Station literature.

\_\_\_\_\_ I agree to pay the nonrefundable \$75.00 team registration fee. I understand that this fee must be paid prior to attending the clinic or tryouts or for my child to be placed on a team.

\_\_\_\_\_ I understand that the \$250 May fee will be drafted on May 18<sup>th</sup> once athletes are placed into work groups and attend the first practice of the workgroup.

- **Monthly Tuition**

\_\_\_\_\_ I agree to pay the monthly tuition depending on the fee structure that I choose and any additional fees that are listed in the team packets. The monthly tuition (fee packages vary) is due by the first of each month. Fees are considered late after the 5<sup>th</sup>. Elite team tuition is \$389 per month, Advanced Prep team tuition is \$324 per month, Prep team tuition is \$259 per month, and Novice team tuition is \$205 per month.

\_\_\_\_\_ I agree to attend choreography camp (Level 3-6 will be the week of July 25-August 2 and Level 1-2 Prep, and novice will be the week of August 3-9th). Exact days and times will be sent closer to the date. Failure to attend camp will result in \$55 per day fee, in addition to your choreography fee, which will be drafted and paid to the person that has to fill in and teach you the choreography.

\_\_\_\_\_ If there is a balance on your account on the 5<sup>th</sup> of each month for any reason, it will be drafted/charged with the tuition and fees on the sixth of the month with a \$25 late fee. I understand that it will be drafted/ charged to my account.

\_\_\_\_\_ All team members will be required to have a credit card on file in order to guarantee their spot. Failure to do so, may result in dismissal from the program.

\_\_\_\_\_ If teams are awarded bids to end of year events, fee deadlines will also be strictly enforced and a separate contract will be implemented for those events. If you pay the year in full upfront, end of the season fees are not included and will need to be paid separate.

\_\_\_\_\_ Fees for team members starting after June 1<sup>st</sup> will be adjusted at the time of sign up due to the schedule of payments of the amortized annual fees that are due that have already been charged to the program.

\_\_\_\_\_ I/we understand that if my account is delinquent over 30 days my son/daughter will be ineligible to compete and may be removed from the team/ routine and until my account is currently up to date.

\_\_\_\_\_ Accounts that are split will be required to sign 2 contracts and have 2 accounts on file by each custodial parent.

- **Early Termination of Contract**

\_\_\_\_\_ If a team member quits or is dismissed for any reason, you will forfeit all fees. Any uniform or uncollected items will also be forfeited and an attempt will be made to sell to other athletes to credit monies toward the unpaid balance. No refunds will be given nor will monies be credited to a class account. Please recall there will be a \$500 contract buyout due immediately for elite or advanced Prep team members and \$250 for prep or novice members.

\_\_\_\_\_ I/we have read and agree to comply with all requirements and rules for the 2026-2027 competitive years. I understand my financial obligations to Cheer Station for my child's participation in their team programs and agree to pay all fees by the required deadlines. I agree to pay all 12 months of tuition or immediately pay the \$250 buyout from the prep program or the \$500 team buyout from the elite or advanced prep program, as well as any past due fees to be released from this contract. I understand that this does not guarantee my child the right to compete or perform unless their attendance is compliant and their skills are ready for the mat. I agree to pay team tuition by the 1<sup>st</sup> day of each month or pay a \$25.00 late payment penalty fee after the 5<sup>th</sup> of each month. I also understand that all uniforms and equipment is forfeited if my child is not able to complete the season.

\_\_\_\_\_ Athletes that cannot complete the season due to an injury will be required to provide a doctors note. Accounts will be dealt with on an as case basis.

- **Practices, Competitions, and Absences**

\_\_\_\_\_ I/we understand that my child may have to miss school to attend a competition. More than likely it will only be a half-day of school except for Summit or All-Star Worlds, where we might have to miss several days. I/we understand that my child may have to sacrifice school sports participation in the fall and early spring because it may conflict with competitions and practices. Athletes are allowed to miss 4 practices from June 1-August 31 and 3 practices from September 1-May 1. Any practices missed above that amount will require the time to be made up or may result in removal from the team.

\_\_\_\_\_ I will arrive at the meeting time the night before all major national competitions to ensure my athlete is rested and to attend any required practices.

\_\_\_\_\_ I understand that there may be practices or meetings during the events and will be required to be at them.

- **Choreography and Camp**

\_\_\_\_\_ All teams will have a Mandatory Team Choreography camp where they will learn their competition routines.

\*Mandatory Elite for Levels 3-6 Team Choreography Camp is scheduled for July 25th-August 2nd.

\*Mandatory Team Choreography Camp for Elite Levels 1-2, prep and novice teams is scheduled for August 3-9.

\*Each team will have choreography around 10-12 hours and exact days/times will be sent closer to choreography.
