AMENDMENT TO ARTICLE 9(j) OF THE DECLARATION OF CONDOMINIUM FOR PINE RIDGE NORTH VILLAGE IV, A CONDOMINIUM

(additions indicated by underlining; deletions indicated by "---")

CHILDREN: RESIDENTS. No person under thirty-five (35) years of age shall be permitted to reside that such persons under age thirty-five (35) years may be permitted to visit and reside for seasonable periods not to exceed two (2) consecutive months on any one occasion and reside (75) days in any calendar year. To demonstrate an years of age shall be permitted to reside in any Unit, except intent by the Association to provide housing for persons 55 years of age or older and inasmuch as Pine Ridge North Village IV was designed as an adult community, it shall be required for all new occupants, as of the effective date of this amendment, that at least one person 55 years of age or older must occupy a unit. Persons under fifty-five (55) years of age and thirty-five years of age or older may reside in any unit, as long as at least one the occupants is over fifty-five (55) years of age. persons who are under age fifty-five (55) (35) or older who are occupants as of the effective date of this amendment may continue to occupants amendment may continue to occupy the unit.
