10 YEAR LIMITED PRODUCT WARRANTY

Kingspan Insulation LLC warrants to the initial owner ('Owner') of a building that the KoolDuct® Insulation Boards ('Product') and ancillaries supplied by them as part of the Kingspan KoolDuct® System are free from manufacturing defect and suitable for their purpose, as recommended or approved by Kingspan Insulation LLC, when designed, fabricated and installed by competent fabricators and installers in accordance with instructions within our current Manufacturers Literature (Specification, Fabrication & Training Manuals) and /or other specific written instruction provided by Kingspan Insulation LLC, and will remain effective for a period of ten (10) years. Upon invoking this warranty, an appropriate sales order must accompany any claims clearly indicating the date of purchase, route to market and specific materials involved.

This Limited Product Warranty shall be in effect only if the Product is installed in strict accordance with installation instructions provided by Kingspan Insulation LLC and accepted industry standards. If the Product fails to meet this Limited Product Warranty during the Warranty Period, Kingspan Insulation LLC, at its option, will deliver to the Owner of the building on which the Product is installed, a quantity of equivalent new Kingspan Insulation LLC product to replace the non-conforming Product or refund the purchase price paid to Kingspan Insulation LLC for the non-conforming Product. Under no circumstances will Kingspan Insulation LLC's liability exceed the purchase price paid to it for the Products. Kingspan Insulation LLC shall have no obligation under this limited warranty until any and all Kingspan Insulation LLC invoices for the Products supplied are paid in full to Kingspan Insulation LLC. The warranty period for replaced material shall be the remainder of the original warranty period. The sole and exclusive remedy for breach of warranty is the remedy of replacement or refund provided herein.

This Limited Product Warranty is available for specified Product purchased on or after January 1, 2017. Kingspan Insulation LLC assumes no liability under this Limited Product Warranty for damages caused by someone or something other than the value of the Product. This Limited Product Warranty shall be void if the Product's performance has been impaired by abuse, mishandling of the Product or by improper installation. Kingspan Insulation LLC does not warrant the compatibility of Product with any product manufactured by any third party, including but not limited to any roofing membrane or coating. This Limited Product Warranty is the user's sole and exclusive remedy for any claim based on failure of the Product to maintain its physical properties whether such claim would arise under tort, contract or statutory law.

Kingspan Insulation LLC expressly disclaims any and all liability for any incidental, special, consequential, or similar damages in connection with the Product or its use, whether or not foreseeable and whether or not Kingspan Insulation LLC has been advised of the possibility of such damages including, but not limited to, incremental heating, cooling or similar costs and any other harm to persons or property.

In order to substantiate any claim under this Limited Product Warranty, the Product must be sampled and tested in accordance with sampling procedures prescribed by Kingspan Insulation LLC, and samples of the Product shall only be taken in the presence of an authorized Kingspan Insulation LLC representative.

The building owners and /or their agents shall have ensured that the design of the building structure, materials and controls supporting the KoolDuct® Insulation boards are adequate for their purpose and properly constructed. Ancillary materials other than those supplied as part of the Kingspan KoolDuct® System are excluded from this guarantee. As Kingspan Insulation LLC neither supply nor manufacture such materials, their suitability and freedom from defect must be the responsibility of their respective manufacturers /distributors. The building owners, accepting that Kingspan Insulation LLC can have no general or special responsibility for the adequacy of workmanship of the contractor, shall have ensured that they and /or their agents have been satisfied that the KoolDuct® Insulation boards have been installed by the contractors in accordance with the guidelines given above.

10 YEAR LIMITED WARRANTY

Any claims under this Limited Product Warranty must be made in writing to Kingspan Insulation LLC at the address above within 90 days of discovery of the issue giving rise to the claim. To be valid, all claims must identify the building address, the warranty claimant and the nature of the claim. If Kingspan Insulation LLC determines that an investigation of the claim is necessary, the claimant must allow access to a Kingspan Insulation LLC representative to view the property specified in the claim, including the taking of photographs and samples as required.

Oral statements made by Kingspan Insulation LLC's representatives and written descriptions of the products appearing elsewhere than in this limited warranty are not warranties and shall not be relied upon. This writing constitutes the final, complete and exclusive expression of the terms of the parties' agreement. Any modifications hereof, to be effective, shall be in writing, shall expressly refer to this limited warranty, and shall be signed by an authorized representative of Kingspan Insulation LLC.

This limited warranty shall be construed and the obligations of Kingspan Insulation LLC shall be interpreted in accordance with the laws of the State of Delaware without regard to the conflicts of laws thereof. Any controversy or dispute arising out of or related to this limited warranty shall be addressed and settled in accordance with the process set forth in Kingspan Insulation LLC's Terms and Conditions of Sale (U.S.) provided to Kingspan Insulation LLC's customer (the "Sales Terms"). This Limited Warranty is issued pursuant to, and in connection with, the Sales Terms, and, except to the extent, if any, that this Limited Warranty directly conflicts with the Sales Terms, this Limited Warranty is subject to all applicable provisions of the Sales Terms. In the case of a direct conflict, the provisions of this Limited Warranty shall control with respect to such limited warranty only.
