# OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), Valli Vineyards Limited (the licensee) is authorised to sell alcohol on the premises situated at 45 Bledisloe Street Kurow 9435 and known as "VALLI Wine Bar", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### Conditions

This licence is subject to the following conditions:

(a) Alcohol may only be sold on the following days and during the following hours:

Monday to Sunday 11.00 a.m. to 11.00 p.m.

- No alcohol shall be sold on the premises on Good Friday, Easter Sunday, Christmas Day or before 2. 1.00 pm on Anzac Day
- A properly appointed, certificated acting or temporary manager must always be on duty and on the premises when the premises are open for 3. the sale and supply of alcohol.
- The licensee must implement and maintain the steps proposed in their Host Responsibility Policy detailing the steps to be taken to promote the 4 responsible consumption of alcohol and ensure there is a safe drinking environment on the premises and ensure that all staff receive training in their responsibilities and obligations under the Sale and Supply of Alcohol Act 2012.
- The licensee shall ensure that the provisions of the Sale and Supply of Alcohol Act 2012 relating to the sale and supply of alcohol to prohibited 5.
- Drinking water must be freely available and displayed whenever alcohol is being supplied during complimentary tastings on the premises.
- There must be no sale or supply of alcohol to minors and a complete prohibition on sales to intoxicated persons and the licensee must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on such sales or supply.
- A manager's register (as required by s.232 of the Act) is maintained and available on the premises. 8.

The Licensee must ensure the following are displayed:

- (i) A sign visible from outside the principal entrance stating the ordinary hours of business where the business will be open for the sale of alcohol.
- (ii) A copy of the original licence with all conditions located just inside the principal entrance where persons entering the premises cast read it. (iii) A sign in a prominent place identifying the duty manager's name.

### 10. DESIGNATED AREAS:

The whole of the premises is designated as a supervised area. (This means no persons under 18 years of age can be in the area unless with their parent or legal guardian). The area from where alcohol is to be sold is described in the plan date stamped as received by the Waitaki District Licensing Committee on November the 9th, 2023.

# 11. REMOTE SALES:

Alcohol sold remotely must not be delivered on Good Friday, Easter Sunday, Christmas Day

or before 1.00pm on Anzac Day and must not be dispatched from the store or delivered between 9.00pm and 6.00am the following day.

- The licensee must take reasonable steps to verify that the buyer and the receiver of an alcohol 12. delivery is not under 18 years of age, and that the receiver (where present) is not intoxicated.
- 13. The delivery package must contain a label with the following words: CONTAINS ALCOHOL
  - No delivery shall be left at the destination without proof of delivery.
    - No delivery shall be made to intoxicated persons or persons under 18 years of age.
- A copy of the license must be displayed in a prominent place on the Valli Vineyards Limited internet site. The licensee must state the licensee's name, license number and the date the license expires
  - on every receipt issued for alcohol sold remotely;
  - in every catalogue, if alcohol is sold by remote sale using catalogues;
  - on the internet site, if alcohol is sold by remote sale using an internet site;
  - If alcohol is sold by remote sale using an internet site, the site must also display either a legible image of the licence, or a clearly d. identified link to such an image.
  - The licensee, if selling alcohol by remote sale by telephone must comply with any regulations made under the Sale and Supply of Alcohol Act 2012 requiring information to be given to callers.

According to the Sale and Supply of Alcohol (Fees) Regulations 2013 fees have been assessed for the premises as Medium.

## Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force:

- either:
- until the close of the period for which it was last renewed; or
- if it has never been renewed, until the close of the period of 12 months after the day it was issued; but (ii)
- if an application for the renewal of the licence is duly made before the licence would otherwise expire, either:
  - until the close of the period of 3 years after the period for which it was last renewed; or if it has never been renewed, until the close of the period of 4 years after the day it was issued. (i)

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, the licence expires on:
