Minutes of ACT - Regular Board Meeting Date: July 12, 2017

Meeting was called to order at: 4:35 PM

- 1. The Consent Agenda was approved (Minutes from last month's board meeting, monthly financials and Center Statistics, this meeting's Agenda)
- 2. A quorum was present for this meeting.
- 3. ED report:
 - a. Expansion project still being considered a Cat Café serving coffee, etc. Exploring funding and feasibility.
 - b. Center is out of space for paper files, etc. that must be kept; looking at storage options and possible use of out buildings.
 - c. IT technology we will need to digitize all our citations per the city of Chattanooga and will also need new iPads as the current ones are old; Must be done this year per City requirements. This is an unexpected expense.
 - d. MAC is currently slammed with cruelty cases that are going to state court:
 - i. Blue truck case of ill dog abandonment.
 - ii. Animal cruelty case -- Collar imbedded in neck of dog.
 - iii. CPD is helping with warrants which we appreciate.
 - iv. Live release rate still 80% but due to large intake and litters of ill kittens coming in, this may go down.
 - v. Adoptions are up due to free adoptions with pet care kit purchase.
 - vi. Transfers are going great thanks to Katie Christy.
 - vii. Reclaims are down, not sure why.
- 4. Lee Towery Laura McCann has not completed the Strategic plan due to the recently hired financial consultant making some suggestions she must institute.
- Lee Towery handed out a suggested MAC Vision Statement which was discussed and minor revisions suggested; Doug Swafford made a motion to accept the statement as edited, seconded by Bruce Baird. Motion was approved by a unanimous "Aye" vote.
- 6. Vision Statement reads: To eliminate animal overpopulation, cruelty, and neglect. To create a culture of compassionate care, community engagement and advocacy for animals by providing programs and education that support people and companion animals.
- 7. Development Committee report by Lee Towery We really need some subcommittees for upcoming events:
 - a. Golf tournament need to start now getting teams signed up so please help!
 - b. Humanitarian Awards need a new venue and ideas for next year's event.

- c. Discussion about continuing need for a development director and funding of this position.
- d. This weekend one of our donors, Mike Lee, is having a brunch at his home to benefit MAC.
- 8. Finance committee report Doug Swafford:
 - a. Donations are over budget
 - b. Clinic is over budget due to influx of animals.
 - c. Special events are under budget.
 - d. Wages and supplies over budget due to raises and number of animals being housed.
 - e. Revenues are up in many areas.
 - f. Gross profit is close to budget.
- 9. Lee Towery report An EC Meeting was held on June 29th to discuss the house bequeathed to MAC; there is a purchase contract offer for \$108,000 which is less than the property's current value; discussed pros and cons of accepting the offer; all agreed with the EC who had voted to accept it at the meeting on 6/29/2017.
- 10. Lee Towery gave a reminder that if anyone on the board still owes any outstanding donations from the Awards Dinner auction, etc. please arrange payment.
- 11. Bryan Harrison fund raising ideas;
 - a. Targeting Micro donors—like the Obama model using texts, apps, FB, etc. to solicit small donations from large numbers of donors.
 - b. Look at other organizations that use these methods to see what/how they are doing.
 - c. Does the board want to do this? All agreed "yes" this was a great idea. Bryan volunteered to take the lead and research this further and report back.
 - d. Humanitarian Awards Dinner need to look at how to attract people that don't necessarily have a passion for animals but like them; need ideas on what we could do to make the event more fun and desirable to more types of people and potential donors. Any ideas would be welcomed.
