# McKamey Office Romance Project Guide Regulations

(Please initial every statement, sign and date at bottom)

\_\_\_\_\_ The animal in your care remains the property of McKamey Animal Center (MAC), and you are hereinafter referred to as the Host applicant.

\_\_\_\_\_ While the pet is in your care, it is still available for adoption. If someone you encounter is interested in adopting your Host pet, please refer them to the Adoptions Supervisor at McKamey.

\_\_\_\_\_ Any and all adoptions for Host animals will be made through MAC. Under no circumstances may the Host applicant release the animal to another party prior to approval from the Foster Supervisor or Director of Animal Care and Placement.

\_\_\_\_\_ The Host applicant agrees not to place the animal in any dangerous situations (i.e. Riding in an open pick-up truck or left unattended in Host location. Host dogs are not allowed to go to off-leash dog parks, or to areas where other dogs are known to be off-leash.

\_\_\_\_\_ The Host applicant agrees to keep all dogs leashed at all times; unattended tethering is prohibited.

\_\_\_\_\_ McKamey animals must have their McKamey ID Tag on at all times.

\_\_\_\_\_ Medical concerns must be immediately reported to the McKamey Adoptions Supervisor, Vet Services Director, or Director of Animal Care and Placement. McKamey will not be responsible for any veterinary bills incurred if the Host applicant takes the animal to a veterinarian without prior approval from one of the aforementioned parties.

\_\_\_\_\_ Any current pets who will interact with the Office Romance pets must be current on their vaccinations. Exposing current pets to a shelter pet does put them at risk. McKamey Animal Center will not be responsible for any illness your animal may contract as a result of exposure to a McKamey animal.

\_\_\_\_\_ I understand that the Office Romance Project shall last no more than four hours and that the Office Romance dog shall be returned to MAC before closing time. For adventures occurring on Tuesday, Wednesday, Friday, Saturday, and Sunday, the Office Romance dog must be returned promptly by 5:00 PM EST. Adventures are not permitted on Thursdays. On Mondays, the Host applicant must establish a set pick up and drop off time directly with the Adoptions Supervisor. No Office Romance adventures are conducted on Holidays. If the Host applicant wants to return the animal past 7:00 PM, he/she is responsible for making contact with the on-call Animal Control Officer at the number provided on the Contact Reference Card.

\_\_\_\_\_ In the event of an overnight emergency (such as the Host applicant being unable to return the animal to MAC before closing) the Host applicant will provide the animal with humane care and maintain them in accordance with all current state, county, and municipal laws and ordinances while they are in his/her care. The Host applicant will provide McKamey pet with adequate food, water, affection, socialization, and exercise as they would their own pets.

\_\_\_\_\_ I understand that MAC and its representatives have limited information regarding the temperament and habits of the Office Romance Host dog. I will take all reasonable precautions through the use of crates, leashes, supervision, and common sense to ensure that the dog does not run loose, become a nuisance, destroy property, injure or be injured by another animal, or injure or be injured by any person or persons. MAC will not be held liable for any damages caused by the Host dog. Any aggressive behaviors must be immediately communicated to the Adoptions Supervisor or Director of Animal Care and Placement.
