All memberships are subject to the approval of the management of Perrysburg Tennis Center.  
No member may sell or transfer his/her membership.  
Memberships and unlimited walk-on options require a 1 year commitment, and are non-refundable.

It is understood that the prospective member assumes no liabilities whatsoever in connection with this membership other than that of payment of membership fees, court charges, usage fees, professional instruction fees, and other charges incurred by the member and his or her family and guests in the use of the Perrysburg Tennis Center. It is also understood that members and guests assume full responsibility for any injuries or losses that may occur while at Perrysburg Tennis Center, and agree to hold Perrysburg Tennis Center LLC, its owners and employees harmless from any claims that result from such injury or loss.

Membership fees, court usage fees, professional instruction fees, and other charges incurred by the member and his or her family and guest in the use of the Perrysburg Tennis Center are nonrefundable and subject to change (such charges and fees will not be applied retroactively).

Members will receive a monthly statement through your listed email account on the first day of every month. Your balance will automatically be deducted from your checking/savings account or credit card on the 5th of each month. All membership fees are subject to current Ohio sales tax and are billed the last day of the month for the upcoming month if you are paying monthly. All full (non-seasonal) memberships are continuous for one full year; this includes the unlimited walk-on option. After your first full year of continuous membership you may choose to continue your membership monthly or pay your membership dues annually. There will be a \$20.00 fee for any returned checks. Perrysburg Tennis Center can send a monthly paper bill through the mail for a monthly fee of \$2 or you can pick up a copy of your bill at Perrysburg Tennis Center.

**Permanent Court Time (PCT):** We offer permanent court time reservations which assures the same court each week for a 12-15 week period of time. This PCT reservation, however, commits the member for that court reservation for the entire session. Permanent courts are billed in 3 installments after the contract has been signed. A member's Permanent court time may be offered for sale at the request of the member. We will make every effort to sell the court. If it is sold, member will not be billed. You may choose to be a full-time or part-time participant in a PCT reservation. You are responsible for finding your own substitutes if you are unable to play on any given day. We will not collect payment from your sub. You are welcome to invite a guest to sub during your PCT. Subs will need to check in at the desk and pay a \$5.00 guest fee. Each guest will be allowed up to 4 visits in a 12 month period.

Please go on the courts only at the start of your scheduled court time, and be prompt leaving the courts at the conclusion of your scheduled court time. White-soled or non-marking shoes are required on all tennis courts. Proper attire, including shoes and shirt, must be worn at all times.

**Cancellation Policy:** All cancellations must be made 12 hours prior to the scheduled program or you will be billed for that event.

**Guests:** Guests are always welcomed at Perrysburg Tennis Center! Each person may be a guest up to 4 times a year for permanent court time or for reserved courts. All guests must be accompanied by a member. The guest fee is \$5 per person per visit for open court time or Permanent Court Time. There is no guest fee for junior or adult clinics or private lessons. Non-members, though, will pay an additional fee of \$3.00 for every clinic or private lesson they take.

**Children:** Children under the age of 8 must be under direct supervision at all times. Child care services are available on weekdays from 9am – noon Mon. A parent must be on premises to have a child in the child care area. As a courtesy we ask that you not bring a sick child to the child care area.

**Towels:** Hand towels and bath towels are available for sale at the front desk.

**Lockers:** Full Lockers are available for daily usage. Sign out a key at the front desk. All items are to be removed from the locker each day. Please return keys before you leave the club.
