## 2022 Posthumous Nomination Form

The Oklahoma Hall of Fame was founded in 1927 to recognize its citizens who are dedicated to the betterment of mankind, illustrate the collective story of our state, and provide educational opportunities for Oklahomans of all ages. To date the Oklahoma Hall of Fame has inducted more than 700 individuals who have provided leadership in times of need, made a meaningful impact on others, and elevated the level of pride in our state. Each Honoree who has received our state's highest honor is part of a unique population of business leaders, public servants, philanthropists, artists, and personalities known outside the limits of their own communities.

To submit an individual for consideration please evaluate the following criteria, assemble the official nomination, and submit the requested information on or before the March 1<sup>st</sup> deadline.

### ELIGIBILITY

To be eligible for induction into the Oklahoma Hall of Fame an individual must:

- be a resident or former resident of the State of Oklahoma.
- have performed outstanding service to humanity, the State of Oklahoma, or the United States.
- have brought honor or distinction to the State of Oklahoma through their efforts and contributions.

### NOMINATIONS

- The Oklahoma Hall of Fame depends on the public to nominate extraordinary Oklahomans.
- An individual cannot be considered for induction if not formally nominated.
- All nomination forms must be complete, well-prepared, and submitted on or before the deadline of March 1<sup>st</sup>.
- It is recommended that the person nominating an individual have a personal relationship with the nominee to better gather and provide complete facts, to fully illustrate the characteristics and achievements of a nominee, and be able to submit current contact information should that person be selected for induction.
- The nominee is evaluated solely on the information you submit. You should assume members of the Selection Committee do not know or never have heard of the individual. Present a compelling, powerful story, highlighting essential and inspirational accomplishments in a concise fashion.
- Nomination forms are valid for three consecutive years. Should your nominee not be selected within a given year, updates to their information are encouraged and should be sent prior to the deadline by using the Nominee Update Form available on our website.

## DETAILS ON EVALUATION AND SELECTION:

- Nominations received within the nomination period, as well as those still eligible during the three-year window, are provided to the Selection Committee for consideration.
- All nominees are evaluated on merit, not endorsement.  
Criteria for selection includes:
  - a. Overall service to others
  - b. Unique contributions
  - c. Examples of leadership (professionally and personally)
  - d. An inspiration to others
  - e. Fostering pride in Oklahoma
  - f. Social, geographic, and professional diversity
- The Oklahoma Hall of Fame receives many nominations within a given year. With 6-8 Honorees selected annually, many deserving nominees, both living and deceased, are not selected for induction when initially nominated. Individuals can be renominated and their information updated annually.

### Required supporting materials:

- Digital, high resolution, color photo of nominee (if available)

### Recommended supporting materials:

- Letters of support (limit 2)
- Vita or resume for the nominee

### Unacceptable items:

- Additional books, videos, or photographs by or of the nominee. As a nonprofit we do not have the ability to return nomination items that are not listed above.
- Nomination materials bound or packaged in an effort to make a nomination standout. All materials are prepared and presented to the committee in a standard format.
