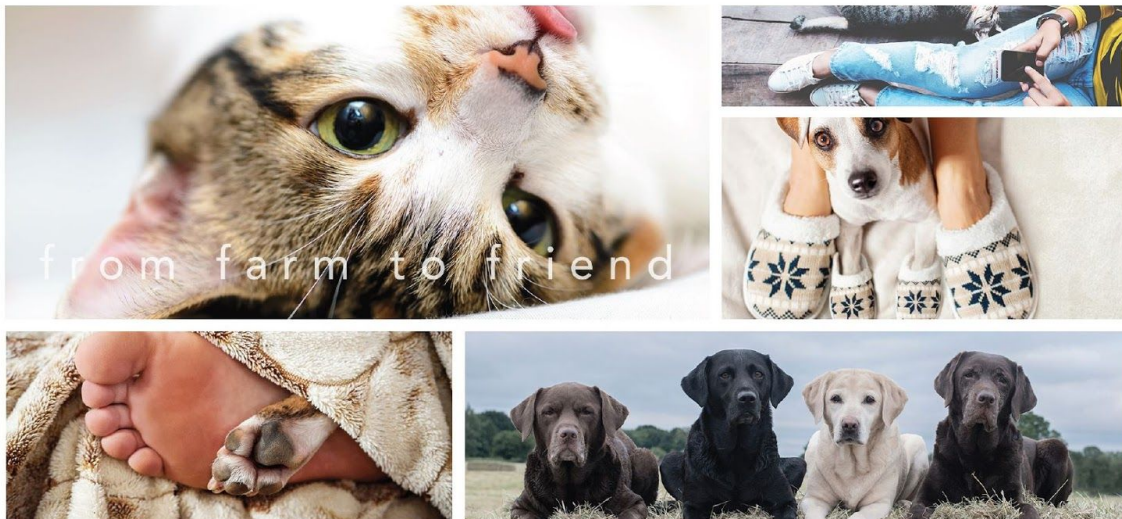

<div>TITRATE DOSE UP SLOWLY AS NEEDED.</div> 	WEIGHT OF PET (LB) 	RECOMMENDED DOSING
	< 5 lbs	3 drops
	10	5 drops
	20	10 drops (approx. 1/4 dropper)
	30	15 drops
	40	20 drops (approx. 1/2 dropper)
	50	25 drops
	60	30 drops
	70	35 drops (approx. 1 dropper)
	80	40 drops
	90+ lbs	45 drops

Ananda Pets should be taken in accordance with recommended dosage. If an entire bottle of Ananda Pets is ingested in one sitting, consult your veterinarian.
