I hereby acknowledge and agree to the following:

- 2. I understand that classes at Harbour Dance Centre may be physically strenuous and I voluntarily participate in them with full knowledge that there is risk of personal injury, property loss or death.
- **3.** I attest that I have no psychological, medical or emotional condition that would prevent me from safe participation in a Harbour Dance Centre dance class.
- 4. Harbour Dance Centre uses third party tools (e.g. Zoom/FitGrid) to provide live-streaming classes. I understand that HDC does not endorse or approve and is not responsible for the privacy practices of these third parties or my use of such third party tools. I also understand and agree that HDC is not responsible or liable for any third party tools used to provide live-streaming classes.
- 5. I understand that some Harbour Dance Centre classes may be live-streamed and that notification of such live-streaming will be placed beforehand outside the studio where such live-streaming will take place. By entering such studio, I will thereby have given my irrevocable consent for HDC to proceed with the livestreaming.
- 6. I agree that neither I, my heirs, assigns or legal representatives will sue or make any other claims of any kind whatsoever against Harbour Dance Centre or its members for any personal injury, property damage/loss, or wrongful death, whether caused by negligence or otherwise.
- 7. And, I hereby release to Harbour Dance Centre the rights to all photography and video recordings that may be taken during classes and workshops for promotional use.
- 8. I recognize that this agreement of release and waiver of liability is a legal contract and that I have complete knowledge of its contents.
- 9. I agree that: I am above the legal age of majority in my province or territory of residence (19 or older in BC) and do not require parent or guardian consent. OR; I hereby warrant and represent that I am the parent or legal guardian of the above-named minor (minors are defined as AGE 18 OR YOUNGER in British Columbia). I consent to and confirm the terms and conditions above. I hereby fully indemnify Harbour Dance Centre, its associated and affiliated companies and their respective directors, employees and instructors from and against any claim, action, liability, settlement, judgment, loss or damage (including but not limited to legal fees) which they may suffer or incur as a result of any death, injury or damage suffered or caused by the above- signed minor in association with their participation in classes at Harbour Dance Centre.
- 10. I have read this agreement and fully understand its contents and meaning, and sign it of my free will.
- 11. By signing this Release of Liability, waiver of claims, assumption of risks and indemnity agreement, you will waive or give up certain legal rights, including the right to sue for negligence or claim compensation following an accident.
