Community Update

Pecos Report - On Monday, April 1st, Stephen Robertson, PBPA's Executive Vice President, attended and spoke at a Town of Pecos City Council meeting regarding an agenda topic providing for discussion of a "No Drill Zone" in the city limits and the extra territorial jurisdiction (ETJ) of Pecos. While other concerns exist, it appears one of the driving factors for the agenda item is future residential development in the area.

In working with the Mayor and City Council, we were able to make sure the city was well aware of state statute preempting municipalities from taking any action effectively prohibiting oil and gas operations. Stephen's comments at the City Council meeting illustrated that the city's leadership could best serve the community by collaborating with companies looking to operate inside the city limits or ETJ and by increasing communications with the Railroad Commission concerning applications filed on lands inside the city limits or ETJ. Hobbs Report - Last week Julie Green, PBPA's Community Relations Coordinator, met with Rebecca Long in Hobbs, New Mexico. Rebecca is the Chair of the Board of County Commissioners for Lea County. They discussed the end of the 2019 New Mexico legislative session and what the legislative decisions were going to mean for Lea County and Hobbs in terms of industry.

While reflecting on the session, Rebecca noted how it had been one of the most difficult ones she's seen in years past but was feeling optimistic that nothing too detrimental was decided upon. Rebecca does think that the smaller victories that the legislature claimed, such as certain penalties and fines to industry producers, will be the strategy going forward for the legislature, in that, they will continue with "chipping away one small victory at a time", which could potentially become a much bigger problem over a longer period.

Rebecca and Julie also discussed that 28 out of the 33 counties in New Mexico, at the same time, pushed back by passing many different resolutions that were pro industry in some way or fashion. Continuing to advocate for oil and gas will be important over the next couple of years and Rebecca hopes that younger leaders will step up to become involved and help on that front, particularly in Lea County but also more broadly through out the state of New Mexico, in the years to come. TxDOT Public Meetings - On March 25th and 26th the Texas Department of Transportation (TxDOT) held public meetings (one in Midland and one in Odessa) to outline and discuss the next major improvements they are proposing for the area in between FM1936 and just east of Business 20 in Midland on I-20. TxDOT detailed their construction plans that included new overpasses, re-configuring existing overpasses and ramps, new main lanes for both directions as well as improving service roads on both sides of the highway. The project timeline projects the developments to get started in late 2020.
