RRC Hearing

The Railroad Commission of Texas (RRC) has scheduled an open meeting on April 14, 2020 to discuss a petition submitted by Pioneer Natural Resources and Parsley Energy on oil market demand in Texas. Because of the obvious limitations in gathering during this time, the meeting will be held online via webcast. Written comments are due at 5pm on April 8, 2020, and must be emailed to RRCconference@rrc.texas.gov. Electronic Communications

As we have become more reliant on the use of electronic communication, we wanted to take the opportunity to remind everyone to be mindful that communications with governmental entities are typically subject to public information requests. In Texas, these records are subject to Chapter 552, Texas
Government Code, and in NMSA.

Through the Public Information Act and the Inspection of Public Records Act, citizens and media organizations can review communications sent to elected officials and their staff in Texas and New Mexico respectively. While these should always be considerations in your communications, they are especially important in these times. Please let us know if you have any questions.

Possible Cutbacks by Saudi Arabia and Russia

By Tweet this morning (April 2, 2020), President Trump provided that he expected and hoped that Saudi Arabia and Russia could cut approximately 10 million barrels of oil production. According to a report by Bloomberg, immediately following the Tweet, Saudi Arabia said it called an "urgent meeting" of the OPEC+ alliance to discuss a "fair agreement," signalling it would only cut output if others do so.

PBPA Annual HSE Bench Marking Study

The PBPA Health, Safety, and Environmental (HSE) Committee is conducting its third annual HSE bench marking survey. This survey allows PBPA member companies the opportunity to compare their safety incident and spill performance to blinded data obtained from peer-companies. We look forward to growing participation in this survey, as we have in previous years, and working towards the improvement of HSE performance in the Permian Basin.

TMFC Proposal on a GCP

The Texas Methane and Flaring Coalition (TMFC), of which PBPA is a member, is circulating a proposed "Gas Capture Plan" (GCP) which will be required for all new wells, if approved. The PBPA Regulatory Practices Committee is currently reviewing and working on comments to the proposal.

This project has a very short fuse and we are asking for a quick turnaround, preferably before noon Friday (tomorrow, April 3rd), for returned comments to committee leadership.

Other News Impacting Oil & Gas Operations

U.S. DOE to Make SPR Storage Capacity Available

Today, April 2, 2020, the U.S. Department of Energy (DOE) announced a solicitation to immediately make 30 million barrels of the Strategic Petroleum Reserve's (SPR) oil storage capacity available to U.S. oil producers due to the combined impacts of COVID-19 and the intentional disruption of world oil markets by foreign actors. The DOE currently intends to make an additional 47 million barrels of storage capacity available thereafter.

To help alleviate financial hardship to the critical American energy sector, President Trump has directed the Secretary of Energy to fill the Strategic Petroleum Reserve (SPR) to its maximum capacity.

China Planning Oil Purchases for Emergency Reserve

According to a <u>report from Yahoo Finance</u>, China is planning to purchase oil for its emergency reserves. In addition to state-owned reserves, China may use commercial space for storage as well, while also encouraging companies to fill their own tanks.

The initial target is to hold government stockpiles equivalent to 90 days of net imports, which could eventually be expanded to as much as 180 days when including commercial reserves. Ninety days of net crude imports is about 900 million barrels for China, according to data compiled by Bloomberg. While the current size of China's state reserves is unknown, and Beijing could use a different method for calculating net imports, oil traders and analysts estimated it could amount to China buying an additional 80 million to 100 million barrels over the



Helpful COVID 19 Information

Update from Governor Abbott

On April 2, 2020, Texas Governor Greg Abbott provided the following updates on the federal Coronavirus Aid, Relief, and Economic Security (CARE) Act and related assistance regarding COVID 19 for small businesses.

Coronavirus Aid, Relief, and Economic Security (CARES) Act

The CARES Act was passed by Congress on March 27, 2020. The programs and initiatives in the Act are intended to assist business owners and nonprofits with current needs due to the COVID-19 crisis.

Following President Trump's signing of the CARES Act, the U.S. Small Business Administration (SBA) and the U.S. Department of Treasury <u>announced</u> a robust mobilization effort of banks and other lending institutions to provide small businesses with the capital they need.

The Treasury and SBA expect to have this program up and running by April 3, 2020, so that businesses can contact a participating SBA 7(a) lender, bank, or credit union, apply for a loan, and be approved on the same day.

Paycheck Protection Program

The CARES Act established a \$349 billion SBA-backed Paycheck Protection Program (PPP) to provide immediate access to capital for small businesses who have been impacted by COVID-

The PPP is specifically designed to help small businesses keep their workforce employed and assist with payroll and other business operating expenses. It will provide critical capital to businesses without collateral requirements, personal guarantees or SBA fees. All loan payments will be deferred for six months. Most importantly, if employers maintain their payroll, certain portions of the loans can be forgiven, including payroll, interest on mortgage obligations, rent and utility payments.

Loans will be available through more than 135 existing SBA-certified lenders in Texas, including banks, credit unions and other financial institutions.

SBA Economic Injury Disaster Loans Update

Due to the CARES Act, small businesses and non-profits can get up to a \$10,000 advance on an Economic Injury Disaster Loan even if a previous application was declined or still pending. For more information, visit the <u>SBA's website</u> and apply for the loan advance <u>here</u>.
