News Beyond the Basin



Congressional
Energy Export
Caucus

Last week, Congressman Jodey Arrington launched the bipartisan **Congressional Energy Export Caucus**. By promoting realistic, responsible, sustainable, and cost-effective solutions and legislation, the Congressional Energy Export Caucus' goal is to reestablish U.S. leadership with a pro-energy trade agenda that creates jobs, rebuilds the economy, modernizes American energy infrastructure, strengthens U.S. security, and maintains global trade competitiveness.

“By unleashing the full potential and power of American enterprise, through free market pro-energy policies, our nation became a net exporter of oil and natural gas last year, creating record jobs for our country,” explained Congressman Arrington. “As the world’s largest oil and gas production center, West Texas energy producers have lead the way in fueling our economy and strengthening our national security through energy independence. I am proud to help establish the Congressional Energy Export Caucus, a forum for bipartisan legislative leadership to advance our country’s future prosperity and security through sound energy policy.”

“One of the most prophetic decisions to come out of Washington D.C. in a generation has been to remove outdated bans on exporting energy to American allies overseas,” said Ben Shepperd, President, Permian Basin Petroleum Association. “A robust system of exports for

oil and gas produced in the Permian Basin is vital to domestic and international energy security and the announcement of the Congressional Energy Export Caucus is a continuance of a free market policy that creates jobs in America and opportunities abroad. We greatly appreciate Congressman Jodey Arrington's continued leadership in the United States Congress and for establishing this bipartisan effort to further support energy producers in the Permian Basin of Texas, New Mexico, and all across America."

Congressman Arrington, was joined in the launch by Reps. Carol Miller (R-WV), Henry Cuellar (D-TX) and Lou Correa (D-CA).



Colorado recently issued an updated draft of its [GHG Roadmap](#) with a public comment period open through October and a final draft being released in November.

Colorado's HB19-1261 requires a 26% reduction cut by 2025 and 50% by 2030. However, Roadmap authors recommend oil and gas emission cuts being more aggressive, with a 33% cut by 2025 and 50% by 2030.

Now, national activist groups (350 Colorado and WildEarth Guardians) are using this GHG discussion as an opportunity to call for closing the Suncor refinery by 2025 and an outright ban on the oil and natural gas industry over the next 8 to 10 years.

THE DAPL IS CALLING FOR SUPPORT

Colorado is seeking additional comment on their [GHG pollution Reduction Roadmap](#) and hosted a public listening session on Tuesday, October 20, 2020 from 5:30pm to 8:30pm via Zoom. At the session, state leadership gave an overview of the Roadmap report and dedicated time for public questions and input.

Submit written comments.

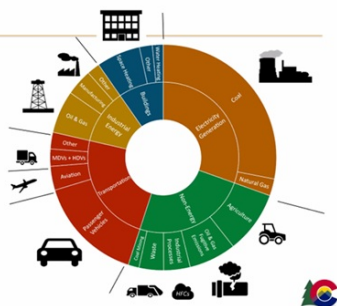
What you need to know:

Two images below illustrate our industry's emphasized role over the next ten years in Colorado. Roadmap authors explain these initial emission reductions for our industry are deeper than HB19-1261, because most sectors of the economy aren't ready to make sizeable cuts. Given our industry's ongoing work in the ozone nonattainment area and the emission reduction efforts related to SB19-181, industry in Colorado is doing a significant amount of work on this front already.

GHG Roadmap

Goals:

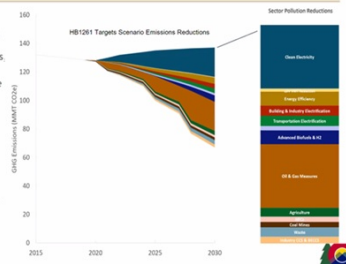
- Accurately assess sources of GHG pollution and progress made to date.
- Identify a series of policy actions and other steps- informed by robust public feedback- to further reduce GHG pollution and progress towards HB19-1261 goals.



Key Findings through 2030

ACHIEVING THE GOALS WILL RELY ON:

- Continued, swift transition to renewables
- Accelerating the transition to electric cars, trucks and buses; making changes to transportation planning and infrastructure to reduce growth in driving
- Accelerating improvements to building efficiency and electrification of buildings
- Reducing methane emissions from the oil and gas industry, landfills, sewage plants and agriculture.
- All sectors have an important role to play in emissions reductions if the state is to reach 90% reductions by 2050.

INDUSTRY SPENDS MILLIONS TO DEFEAT ALASKA MEASURE

Oil companies are spending millions to defeat a ballot measure in Alaska. [Ballot Measure 1](#) would raise the tax on oil and gas produced in certain areas of Alaska's North Slope.

So far, OneAlaska, the opposition campaign, has received more than \$18 million in total, mostly from ConocoPhillips, BP, ExxonMobil and Hilcorp, [according to state finance reports](#). Meanwhile, the pro-ballot advocate Vote Yes for Alaska's Fair Share has garnered \$1.3 million, according to the state data.

Backers of the measure argue a broken oil tax system has led to a budget crisis in the state, since the state — which does not levy a state sales tax or personal income tax — relies on the oil industry for such a large share of its revenue. "Every community has been hurt in some way by our oil production revenue crisis," said David Dunsmore, campaign manager for Vote Yes for Alaska's Fair Share, which supports the push for a tax hike. "People are anxious to fix it."

Groups opposing the measure say it would increase severance taxes by between 150 percent and 300 percent depending on oil prices. ConocoPhillips spokesperson Natalie Lowman said in a statement the company would shrink its investment in the North Slope if the ballot measure passes, and warned the industry may simply leave Alaska with no activity next year in some big fields.

"While we have years of development opportunities in Alaska, passage of BM1 would reduce the attractiveness of our Alaska investments compared to other opportunities in our portfolio," she said. "A shift in capital from Alaska to elsewhere would be a rational response to passage of BM1."
