State of the Oil and Gas Industry



Diamondback Energy invited PBPA to participate in its State of the Oil and Gas Industry activities last month where Legislators from across the state were joined by local elected officials including State Representative Brooks Landgraf and Speaker Tom Craddick. The events included a dinner and a rig tour for elected officials followed by the Midland Chamber hosted luncheon.

The luncheon, sponsored by PBPA Member XTO, and headlined by PBPA Board Member and Diamondback CEO Travis Stice, focused on the long term health and success of the industry in the Permian Basin. The remarks were a great reminder of the importance of the industry and the impact the Permian Basin has on international markets.

Stice said "I believe our future is vibrant if we tackle these challenges like we've tackled challenges in the past. Face them with eyes wide open and be transparent. While these challenges are different than we've faced before, they are solvable. Failure is not an option."

New Mexico Legislative Update

With just over a week to go in the Session, PBPA remains focused on working with legislators and elected officials to advance our priorities. Additionally, PBPA has testified in support of several key pieces of legislation as they make their way through the waning days of the legislative session in the Roundhouse.

These bills include HB 104, which would allow private donations for county road construction projects and provide a tax credit for those donations, HB 276, which would provide a tax deduction for county road fund donations, HB 307, which would speed up contracting processes for much needed road construction, and HB 327 in support of the Eddy County Southeast Road Loop. Of course, we also opposed legislation which would place a ban on hydraulic fracturing and HB 173, which would have added an extra \$.30 tax on each gallon of fuel sold. That bill died in committee this week.

The PBPA is in the Capitol every day sharing the positive message that a vibrant, safe and responsible oil and gas industry benefits all New Mexicans.

Rules Announcement

Today, the Texas Railroad Commission met to work through their <u>previously</u> <u>posted agenda</u>. All items on the agenda were passed through consent, with the exception of items 55, 56, 64, 73, and 90.

Additionally, the Railroad Commission approved two rulemakings. The first included proposed amendments to §3.30 regarding the MOU between the RRC and the Texas Commission on Environmental Quality. The second included adopted amendments to §3.40 regarding depth severances. Both items will be published in the Friday, February 28, 2020, issue of the Texas Register. The comment period for the proposed amendments to §3.30 will end at noon on Monday, March 30, 2020. The adopted amendments to §3.40 will be effective on Tuesday, March 3, 2020. Oil Production from Department of the Interior Managed Leases Surpasses 1 Billion Barrels for the First Time in History Under the Trump Administration

WASHINGTON - The Department of the Interior announced today that over one billion barrels of oil were produced in Fiscal Year (FY) 2019 from leases on federal and American Indian-owned lands and offshore areas — a historic milestone. This is greater than a 29 percent increase in production compared to the end of the previous Administration, which totaled 808.7 million barrels in FY 2016, and represents a 122.5-million-barrel increase in production compared to FY 2018.
