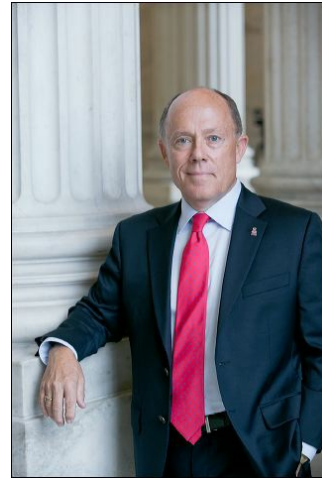
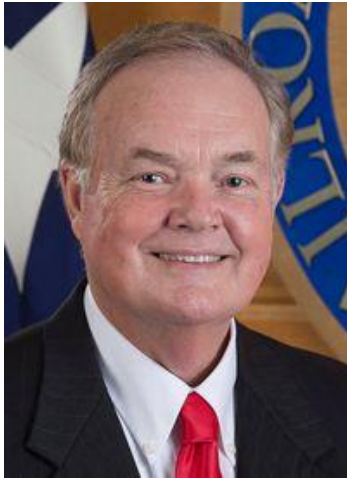
Need to Know

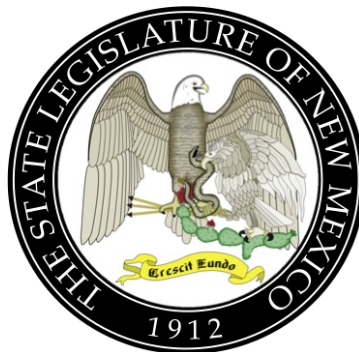

NM Revenue Stabilization and Tax Policy Committee Meeting

On September 26 & 27, 2019, the New Mexico Revenue Stabilization and Tax Policy Committee met in Santa Fe. Most of the items on the agenda related to the impacts of the oil and gas industry on the state's budget and economic outlook. The overall message repeated this year's theme message: the industry continues to be a major contributor to state coffers, but lawmakers should resist relying on these volatile funds. RULES ANNOUNCEMENT

Proposed Rulemakings: §3.70, Chapter 8, and Chapter 9

At its open meeting on October 1, 2019, the Railroad Commission proposed three rulemakings. First, the Commission proposed amendments to §3.70 regarding production and flow lines, permit renewals, gathering pipelines, and certain fees. Second, the Commission proposed amendments to various rules in Chapter 8 regarding HB 864 and HB 866 (2019) and HB 2982 (2013), gathering lines, federal updates, construction reports, and penalties. Third, the Commission proposed amendments to various rules in Chapter 9 regarding HB 2714 (2019), NFPA updates, and other clarifications. All three proposals will be published in the Friday, October 18, 2019, issue of the Texas Register; all three public comment periods will end at noon on Monday, November 18, 2019. Requirement to File Well Logs Electronically

Starting on September 1, 2018, the Railroad Commission of Texas began requiring oil and gas operators to file well logs online. Later this month, we've been told all those operators who have not been doing so will be giving their final notice of this change.

Congressman Arrington and EPA Announcement in Lubbock:

On August 29th, PBPA traveled to Lubbock to visit with our friend and lawmaker, U.S. Congressman Jodey Arrington about a new EPA rule that would benefit West Texas oil and gas producers. Congressman Arrington was joined by the Deputy Regional Administrator for the EPA, David Gray, while announcing the proposed changes to a burdensome and costly federal regulation, currently impacting industry. The proposed amendments to the existing rule would remove a regulatory duplication, saving industry millions of dollars in compliance costs each year, while maintaining health and environmental protection. Carlsbad Energy Summit:

The Mayor's annual Energy Summit in Carlsbad was held on September 12th and PBPA staff, as well as many members, were in attendance. The focus of the summit this year was on Workforce in the industry. The speakers spoke to the crowd about many different topics, including but not limited to, what their ideal workforce looks, is currently needing, and the direction it is headed. PBPA's hard work at advocating for the welfare of the oil and gas industry and its communities, was graciously acknowledged at the summit, but all of the hard work would be for not, without our wonderful members and their support.

On October 17, 2019, the Texas Senate Select Committee on Mass Violence Prevention & Community Safety will be holding a public hearing in Deaderick Hall on Odessa College's campus. Senator Joan Huffman will be chairing the hearing.

The Committee will hear invited and public testimony on the following interim charge:

Learn firsthand, the personal, family, and community impact of mass shootings in Texas by hearing from victims of mass violence in Dallas, Santa Fe, Sutherland Springs, El Paso, and Midland/Odessa.

If you are interested in providing written testimony, it is requested that you submit that testimony in 20 copies with your name on each copy to the Committee during the hearing. The Committee will keep public testimony open until at least 7:00 PM to ensure all person have an opportunity to testify after normal business hours.

As an association, we are only as strong as our members. And to that end, the advocacy work we do on behalf of the industry is bolstered by the good work of our members. Recently, Noble Energy released its first Climate Resilience Report, which discusses steps the company has taken to foster responsible, sustainable operations and provides data showing how they are managing climate-related risks. The Report provides that Nobel Energy has been able to reduce its greenhouse gas emissions intensity by more than 50 percent over 10 years and sites that by using the International Energy Agency's (IEA) World Energy Outlook 2018 Sustainable Development Scenario (SDS) to assess Nobel Energy's business strategy against a 2°C low-carbon scenario, they are well positioned with low-cost assets to drive sustained shareholder value. If you live in the Carlsbad area or Chaves, Eddy, Lea, Lincoln, or Otero Counties, then the Desert Willow Wildlife Rehabilitation Center is the place to call to get your questions about injured or orphaned wildlife answered and the place to bring these animals if Center staff so advises. The Center is located at 512 Fiesta Drive in Carlsbad and has highly skilled staff and enclosures for housing a diversity of wildlife while they are being rehabilitated. The Center is in the process of expanding their facilities for medical treatment of wildlife, which will further enhance their abilities to serve the wildlife rehabilitation needs of southeastern New Mexico. These needs have expanded in recent years as the southeastern part of the state has seen increased development. Upwards of 600 animals typically pass through the Center's doors in a given year.
