Primary Elections in Texas

This week, both major parties hosted their respective primaries across the state of Texas and more than 4 million Texans answered the call and voted in both the Democratic and Republican primaries during early voting and on Election Day.

PBPA stays engaged on elections from the courthouse to the White House because like the energy our members produce, these elections have profound impact on the world we live in and this election cycle was no different.

Republican incumbent Railroad Commissioner Ryan Sitton looks to have been defeated by political newcomer Jim Wright who will serve as the Republican nominee and face either Chrysta Castaneda or Roberto Alonzo, who will battle in May to determine the Democratic Party's candidate in the November General Election.

In CD 11, the race to replace retiring Congressman Mike Conaway, August Pfluger emerged ahead of nine other candidates to avoid a runoff in the Republican primary and will face Jon Mark Hogg who ran unopposed in the Democratic primary.

In most of the Permian Basin, incumbents like Speaker Tom Craddick and Vice-Chairman Brooks Landgraf had no opposition and those that did, like Chairman Drew Darby handily dispatched their challengers.

But at the end of the day a very serious political reality affects the Permian Basin. While the region accounts for the majority of Texas' energy revenue in taxes and more, it has a small share of elected representatives. In fact, the Permian Basin truly only has representation from 3 members of the United States House, 3 members of the Texas Senate, and about 10 members of the Texas House. To put that into context, Harris County alone has 8 members of the U.S. House, 7 members of the Texas Senate, and 24 members of the Texas House.

And just like Permian Basin energy impacts the entire state, elected officials outside our region can still greatly impact the Permian Basin. Through legislation or regulation the impact of members far from West Texas can have a huge impact on what happens here. That is why we keep an eye on the bigger picture.

ERCOT Market Summit 2020

On February 25, 2020, PBPA EVP, Stephen Robertson, participated on a panel at the Infocast ERCOT Market Summit for 2020. The panel topic was Meeting the Needs of the Oil & Gas/Petrochem Industries in Texas. Also participating on the panel were Coleman Lewis from Pioneer Natural Resources and Randy Smith with Oncor, stepping in for John Kemp with Core Solar who ended up not being able to attend.


The panel discussed the electrical demand, and growth in that demand, in the Permian Basin as well as constraints on growth because of lacking infrastructure. It gave PBPA a great opportunity to continue sharing information on the challenges facing the Permian Basin with those outside the oil and gas industry. The release of the ERCOT Delaware Basin Integration Study, the Permian Basin Improvement Plan Ideas being worked on by PBPA, other customers, ERCOT, PUC, and the utility providers, along with the work of the PBPA Electrical Coalition and our staff's continual outreach is making a great impact in helping to not just find, but realize solutions for the electrical transmission and distribution challenges in our region.

Permian Basin Water Management Council

On February 26, 2020, PBPA participated in a quarterly meeting of the Permian Basin Water Management Council. This is a group of corporate water folks, some from E&P companies some from contractors, who get together to discuss water challenges in the Permian Basin. Meeting attendees heard from Keith Gardner on legal concerns regarding New Mexico's 2019 produced water bill (HB 546) and from Dr. Kenneth Carroll with New Mexico State University on the New Mexico Produced Water Research Consortium.

Mr. Gardner shared some drafting concerns with the original HB 546, specifically that there is a reference to the plural "Transferees" that could confuse the interpretation of liability and ownership of produced water. It is possible this confusion could be cleared up by the Water Quality Control Commission of New Mexico, by litigation, or by new legislation. We'll continue to track this issue to work towards a solution for the Permian Basin oil and gas community.

The New Mexico Produced Water Research Consortium is a group of academics, industry representatives and others, looking for solutions to produced water clean up, use, or disposal. Sitton Flaring Report

On February 19, 2020, Commissioner Ryan Sitton released his <u>Report on Flaring</u>, which, among other metrics, measures flaring intensity in Texas compared to flaring intensity in major producing countries around the world. The report also identified flaring intensity associated with several companies in Texas, showing

both those companies with low flaring intensities and those with comparably high flaring intensities.

Commissioner Sitton provided that the report would be updated and published quarterly to track changes as additional infrastructure comes online. Commissioner Sitton did mention the voluntary efforts taken by many companies in Texas to reduce theif flaring volumes, and commended those companies for doing so.

Regulatory Forums

On December 13, 2019, the RRC announced several one-day Regulatory Forums to be held in the spring. Two of these forums will be in Midland on April 1 and April 2, 2020. The Commission is hosting these forums to educate and train energy industry representatives on a variety of topics including: drilling permitting; completions; Form P-16, Acreage Designation; injection well permitting; and, pipeline permitting.
