Regulatory Updates



PBPA's working group continues to develop comments on the New Mexico Departments of Environment (NMED) and Energy, Minerals and Natural Resources Department (EMNRD) draft rules regulating waste, volatile organic compounds (VOCs) and oxides of nitrogen (NO_x). Accepting Comments on Revisions to Statewide Rule 32 Exception Data Sheet

The Railroad Commission of Texas (RRC) is accepting public comment on proposed revisions to Statewide Rule 32 Exception Data Sheet, *Application for Exception to Statewide Rule 32*. The Statewide Rule 32 Exception Data Sheet is filed when an operator requests authority to flare or vent gas.

The proposed amendment to the Statewide Rule 32 Exception Data Sheet will improve the effectiveness of the RRC's Rule 32 exception program by:

- requiring operators to more thoroughly document the circumstances surrounding the need to flare gas;
- providing the RRC accurate information to assess compliance with the flare/vent authority; and
- encouraging transparency in understanding the broader needs and reasons for flaring and/or venting during oil and gas production operations in Texas.

Notice to Pipeline Operators: Recent Amendments 16 TAC §3.70 and Updates to the Pipeline Online Permitting System

On September 1, 2020, the RRC will require pipeline operators to file for the renewal of their pipeline permits by the last day of their designated month. This is in accordance with amendments to 16 Texas Administrative Code (TAC) §3.70 which were adopted by the RRC on January 6, 2020 and take effect on September 1, 2020.

Every permit must be renewed annually, online using the Pipeline Online Permitting System (POPS) available in the RRC Online System. The month that renewal is due is determined by the first letter of the operator's name. The updated POPS user manual is available on the RRC website at <https://rrc.texas.gov/media/32799/pops-user-guide.pdf>.

In addition, the amended rule outlines that late charges for mileage fees due in 2021 or later are reduced for companies who operate less than 50 total miles of permitted pipelines. The updated late charges are \$125 for less than 30 days late, \$250 for more than 30 but less than 60 days late, and \$350 for greater than 60 days late.

Amendments to 16 TAC Chapter 8 were also adopted by the RRC on January 6, 2020. The term lease line was removed as a qualifier to determine if a pipeline needs a (T-4) permit to operate in Texas. The RRC has clarified the definition of a gathering line for permitting purposes. The changes outlined in 16 TAC Chapter 8 and §3.70 together determine which pipelines need a permit.

The designated security administrator may create accounts with appropriate rights for staff within their organization enabling those designees to file forms electronically through the RRC Online System available at <https://webapps.rrc.texas.gov/security/login.do>. For additional information on the RRC Online System, visit the RRC website at <http://www.rrc.texas.gov/about-us/resource-center/forms/online-filing-at-rrc/>. Existing users with accounts in the RRC Online System do not need to designate a new administrator. The organization's security administrator needs only to assign rights for filing online through their administration accounts to grant their users access.
