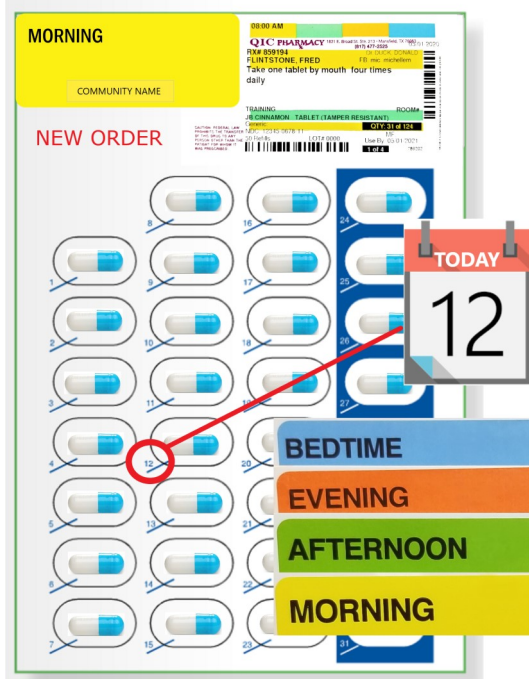

THE CALENDAR DAY CYCLE

The Calendar Day Cycle combines the date and time accuracy of compliance packaging with the functionality and simplicity of the blister card.

New orders, changes and discontinue orders are no problem with this system. You will have the ability to pull any card from a cart and compare it to your MAR for auditing. An interrupted med pass can be easily continued, even by a different staff member, without concerns of med errors.

The bulk of your community's medications are checked in on one day, eliminating time consuming reorders and giving staff more time each day for resident interaction.

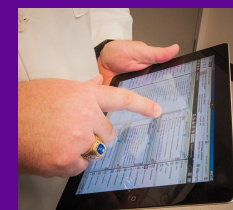
